-	-	<p>State Enterprises “Odessa Commercial Sea Port”, “Illichivsk Sea Commercial Port”, Pivdena Customs of Mindokhodiv and other participants of the transport process are continuing test operation of the Port Community Information System (hereinafter – “PCIS”).</p> <p>According to the information of the Pivdena Customs, Mindokhodiv, (Letter dated 19.09.2014 # 13617/15-70-51) as of today 438 freight forwarding companies, 16 agency organisations (marine agents) and 20 sea lines possessing the functioning electronic digital signature (EDS) obtained in accordance with the established procedure have joined PCIS.</p> <p>From the commencement of the PCIS test operation as at 18.09.2014 the “Odessa-Port” Customs Checkpoint, Mindokhodiv, has accepted and processed in PCIS 112,913 work orders and electronic documents. Total number of containers entered in the System under electronic orders is 198,914 units.</p> <p>Within a period from 02.09.2013, since the beginning of the implementation of the “Single Window – Local Solution” pilot project that introduced the use of the program-information complex “Port Community Information System”, the “Odessa-Port” Customs Checkpoint, Pivdena Customs, Mindokhodiv, has accepted and processed 76,206 orders and electronic documents. Total number of containers entered in the System under electronic orders is 135,700 units.</p> <p>Since 07.08.2014 it has become mandatory for the freight forwarding companies of the Illichivsk Sea Commercial Port to have their orders issued in the electronic form in parallel with the paper orders for the goods transported by rail and disbanded containers</p>	

		<p>with consolidated cargoes.</p> <p>The “Illichivsk” Customs Checkpoint, Pivdenna Customs, Mindokhodiv, had accepted and processed 9,923 electronic orders for 20,816 containers of goods. At present all freight forwarding companies and agency organisation are working with electronic orders.</p>
