## Dear Andriy Mykolaiovych,

The Ukrainian National Committee under the International Chamber of Commerce, in pursuance of performing the functions of the Secretariat of the Interagency Working for Implementation of the "Single Window – Local Decision" Technology in the Operations Area of Pivdenna Customs and Ports of Odessa Region, is analysing and generalises the current state of the said pilot project implementation for the purpose of preparing the information and report to the Prime Minister of Ukraine.

Thus, Paragraph eight, Item 7, Standard Process Scheme of Admittance through State Border of Persons, Road, Water, Railway and Air Transport Vehicles, Carriers and Goods that are Transported by them approved by Resolution of the Cabinet of Ministers of Ukraine dated 21.05.2012 # 451 (the version of the Resolution of the Cabinet of Ministers of Ukraine dated 03.07.2014 # 533) (hereinafter – SPS # 451) stipulates that upon introduction of the Port Community Information System in the sea port it shall be used by the administration of the port and public bodies authorised to carry out the appropriate types of control at the state border checkpoints as regards the economic subjects that carry out their activities in the port during operations with goods and transport vehicles. The Port Community Information System is used under agreements of information cooperation concluded by the State Enterprise "Administration of Sea Ports of Ukraine" with each of such public bodies and economic subjects.

In consideration of the fact that the Port Community Information System has been commissioned by the Odessa and Illichivsk Sea Ports (within the framework of the Process Schemes approved by the Administrations of the Ports), and its operation is being tested at the Port of Yuzhnyi, for the purpose of meeting the requirements of SPS # 451, identifying the circle of the public bodies and economic subjects that exercise their powers and carry out their activities in the Odessa, Illichivsk and Yuzhnyi Sea Ports, which have to join PCIS by means of signing a corresponding agreement of information cooperation with SE "ASPU", we request you to us a list of the public bodies and economic subjects, which have joined PCIS and the list of the public bodies and economic subjects, which have not yet joined PCIS, and give the reasons, due to which the latter do not meet the requirements of SPS # 451.
